With the Private Label Rights to this product, you can do any or all of the following:

1. **Convey Give Away or Resell Rights to the report.** You can give or sell the report away at any price you wish. Note that you can add your own name as the author or even change the product's title.
2. **Add content to your eZine.** Give this report away to your subscribers as an incentive for subscribing to your eZine.
3. **Insert your own One Time Offer in the One Time Offer page.** You can get a chance at making money from your new subscribers upfront by inserting your One Time Offer sales letter so that your prospect will read it before downloading the report.
4. **Use the eZine issues and start your own eZine.** You can edit, add, remove, or change titles of the pre-written eZine issues that come with the Private Label report. This way, you can now start your own eZine or newsletter of your own without much hassle.
5. **Insert affiliate links in the report and eZine issues.** Earn back-end income on auto-pilot by inserting your own links or affiliate IDs into the report for give away and eZine issues as they are sent out to your subscribers. Anyone who purchases through you as a result of clicking on your affiliate link earns you money!
6. **Create a free viral eBook.** Add your resource box/byline to some of articles and create a free eBook. You could allow other people to give away the eBook for free or as a bonus product. They will multiple your ad like a virus. You also could submit it to some free eBook directories.
7. **Create a series of contents for your web site.** Add your own resource box/byline to the articles and publish them on your web site. You could allow your visitors to republish the articles if they also publish your resource box. This will spread your name and business information all over the Internet and increase your link popularity for free.

Those are just a few of the many ideas, the possibilities are virtually endless!

The Only **Restrictions** are:

1. You **CANNOT** sell or give away the re-brand-able/ re-editable/ re-sell/re-author/ re-writeable Private Label Rights the product, as I am doing here.
